**Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.**

With 2 years project experience regarding expenditures, strategic consideration is being given for either re-distributing funds between categories or offering an additional 2 bedroom PSH unit. The de-obligated leasing amounts were directly related to the length of time it took to screen/document two(2) families to enter the program in the first year along with actual housing cost during the 2nd year. With PARC's focus of identifying community partners and resources for client services so that our funds are "resources of last resort", this has diminished the use of each grant year's funds. Specifically, funds allocated for support services (other than case management) were not requisitioned as projected. The residents in this project obtained and are maintaining housing stabilization, minimizing their need for additional supportive services this past year. However, since funding cuts of community resources are now being experienced, PARC staff are vigilant in discerning the needs of these clients being served so that appropriate supportive services and operating expenses can be accessed. To that end, we are increasing case management strategies for empowering client in life skills along with providing support services that will encourage their focus, abilities and confidence for "move on" explorations if they so choose.

### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

This PSH program, which commenced 01-01-15 in conjunction with Virginia State Action Plan for ending veteran's homelessness, serves two(2) chronically homeless households with children in the Portsmouth community in a two (2) bedroom unit and a three (3) bedroom unit, respectively. This is a collaborative effort by PARC with member agencies of the Portsmouth Homeless Action Consortium (PHAC) through the Central Intake/Coordinated Assessment process. The goal is to provide housing stabilization as rapidly as possible to address issues and barriers identified through the assessment process. As current households "move on" so that a unit becomes available, referrals will be considered that meet the HUD definition for chronic homelessness, are identified highly vulnerable with scoring on the VI-SPDAT and referred through our PCAN process. Accordingly, the client families: 1) are assessed for psycho-social, educational, psychological, financial, and physical status at the beginning of the program; 2) receive appropriate referrals to community services for support and barrier reduction relative to the assessment outcomes; 3) receive rental subsidies for housing, located within Portsmouth; 4) receive transportation assistance if warranted; and, 5) receive basic needs and household support. PARC holds the leases to the necessary properties and makes them available to clients on a sublet basis. PARC has identified housing in the Portsmouth community in a private housing complex. The scale of the housing is such that one family sublets each unit. Therefore, one 2-bedroom and one 3-bedroom units are used in this project. Basic housing amenities are located within 5 miles of the two units. Access is available through the bus system to hospitals, grocery stores, clothing, mental health, public health, and social services. Both apartments are located within 2 miles of the town amenities. Bus tickets and/or mileage reimbursement for client owned vehicles is available, if needed. The housing is accessible depending on the clients' needs. The case manager collaborates with the clients to determine acceptable accessibility. Proactive attention will identify and enroll Medicaid-eligible program participants. Services include but are not limited to: in-home support services; basic life skills support; connections to benefits through the SSI/SSDI Outreach Access and Recovery (SOAR) model; access to medical, mental health, and dental care; tenancy stabilization skill development; landlord mediation; budgeting; and increasing community integration through volunteerism, classes, and employment. In addition to helping residents connect to mainstream services and resources PARC provides many services in partnership with other organizations for mental health, substance use, medical and dental care.
