DOWNTOWN - Lisa Murphy, of Wilcox & Savage, P.C., requests a Use Permit for a five-story 60-unit multi-family apartment building elevated upon a one-story parking structure at 700 Crawford Street. The property consists of 0.99 acres and the proposed density is 60 dwelling units per acre. The property is zoned Downtown (D1) in the T6 sub-district. The Future Land Use Map of the Build One Portsmouth Comprehensive Plan designates this property for Mixed-Use Downtown. The property is owned by the City of Portsmouth. Planning Commission recommends approval with conditions. (Roll Call Vote)
