Leighton Lord III of Nexsen Pruet, LLC, on behalf of BKT Enterprises, L.P. for the closure of a portion of Belmont Avenue in order to conduct redevelopment of their adjacent property occupied by Southeastern Freight Lines trucking company. The Future Land Use Map of the Build One Portsmouth Comprehensive Plan designates the property for Transportation. The property is right-of-way owned by the City of Portsmouth.
